

Background

The Rules of Shooting and Range Safety/Control as published by Archery GB/GNAS and any subsequent amendments apply at all times and shall be observed. **All Members and in particular new Members** are strongly advised to read and familiarise themselves with the Club's Shooting Rules, a copy of which has been issued to everybody and is also available on the WAC Website.

The hazards identified below are those considered to pose significant risk. Hazards and their risks will be kept under constant review. Refer to the "Health and Safety: Policy and procedures" document (on website) to determine how risks are rated.




